






Number of single-window transactions for mobile vehicle licenses in 2022 compared to 2021




Number of single window transactions for Micro Companies in 2022 compared to 2021



First: Studies and Commercial Support Department

The Department conducts inspection rounds and monitors prices through cooperative societies and parallel markets.

This is in addition to keeping an eye on prices in the different seasons to ensure keeping them within limits, monitoring seasons exploitation by outlets, protecting consumers and applying market laws and regulations.

Second: Department of Technical Staff of the Advisory Committee for Commodities and Prices Oversight

- Linking cooperative entities and central markets through an automated program to oversight consumer prices for basic foodstuffs.
- Following up and forming work teams to follow up on food markets for the holy month of Ramadan to maintain and stabilize foodstuff prices for consumers.
- Following up construction markets for construction materials for consumers of (iron/cement/ bricks, etc) materials.

Third: Consumer Protection

Consumer Protection is one of the effective supervisory entities in the process of protecting society members against exploitation and combating fraud, so as to ensure their safe transactions when purchasing their needs of goods and the services they deal with. This is in addition to improving their intellectual status through awareness and ensuring the right of workers in the commercial sector in a manner that guarantees commercial activities' freedom of practice and fair competition.

In light of the above, the responsibility of the Ministry of Commerce and Industry, represented by the Consumer Protection Department, is determined by the laws implemented by that Department:

- Law No. (2) of (1995), and the laws amending it, regarding sale prices.
- Law No. (20) of (1976), and the laws amending it, regarding the suppression of fraud in commercial transactions.
- Law No. (10) of (1979), and the laws amending it, regarding the supervision of trade in goods and setting the prices of some of them.
- Decree No. (23) of (1980) regarding the supervision and control of metals and precious stones.

Stemming from the Ministry's keenness to protect consumers against fraud, and for public interest, Resolution No. (368) of (1988) has been issued to form a committee to study consumer protection laws in order to indicate deficiencies therein or any application problems, as well as to suggest appropriate solutions to remedy or overcome such problems. During the year (1989), the committee has reviewed all aforementioned laws and submitted its proposals on the amendments required thereto.

In addition to the above, the Ministry pays great attention to the efforts exerted to enhance its procedures set for protecting consumers and combating commercial fraud in all forms, through the agencies and centers affiliate thereto, covering various regions, as well as by organizing continuous inspection campaigns on markets, receiving complaints from the public and addressing them pursuant to the legal procedures in place. This is in addition to issuing simplified pamphlets to educate consumers about their rights and duties. The following are the key achievements attained in this regard:

Discounts and Prices

- Announced sale transactions (goods services crafts) recorded 175 transactions, with an increase estimated at approximately 40% for the year 2021.
- Sale activities have recorded a noticeable increase during 2022, estimated at about 18%, with transactions amounted to (1056), compared to (1284) transactions in 2021.
- Special Offer transactions (in cooperative societies / supermarkets) have witnessed (317) transactions in 2022, with an estimated increase of about 30% compared to 2021.
- The number of Special Offer transactions (in commercial shops) amounted to (43), with an obvious decrease of about 48% compared to last year.
- Distribution Offers (coupon, brochure, discount brochure) witnessed the number of (6) transactions, with a noticeable increase, estimated at 71%, compared to previous year.
- Free prize withdrawals amounted to (1825) transactions in 2022, with an estimated increase of 7% compared to 2021.




- Number of discount offers (coupon, card, brochure) for an organizer of a group of stores is estimated at (8) transactions, with a 50% decrease compared to previous year.
- The number id seasonal and emergency offers transactions was (436), with a significant increase of 466% compared to previous year.
- Transactions linking local price to the prices on foreign and international websites and electronic applications amounted to (24) transactions, with an increase of 41% compared to 2021.
- Cashback activity transactions amounted to (11) transactions in 2022, with a decrease of 120% compared to 2021.

Statement of the number of transactions conducted by the Consumer Protection Department during the year 2022









Reviewing the annual statistics of the Commercial Control Department inspectors' works revealed an increase in the number of: licensing violations by 428%, seizure reports by 10% (4064 reports), store closures by 166% in 2022 compared to 2021. However, the number of complaints and calls to hotline (135) decreased by more than 90%, and the number of complaints submitted via the portal increased to reach 4969 complaints.











An indicator of the number of most important transactions for auditors and auditors during the year 2022


Indicator of the Transactions of Joint Stock Companies' Branches During 2022



Percentage distribution of total Persons Department transactions during 2022










Percentage Distribution of Import Licenses During 2022





Percentage Distribution of Non-Inlaid Metals During 2022






Explanatory Statement of the Numbers of Real Estate Appraisers Profession During 2022



Statement of the number of transactions for the Trademarks Section during 2022






Percentage distribution of the key transactions of the Patents Section during 2022




Third: Gulf and Arab World Affairs



Work Methods and Service Development Section:

Work Methods and Service Development Section is one of the key sections in the Administrative Development and Training Department, especially in the year 2022, when we began actual implementation of the services digital transformation at the Ministry of Commerce and Industry, through (Sahl) application and the ESCWA, which aims to gather all electronic government services in all Arab states, provided by individuals and business sector, in cooperation with the Central Agency for Information Technology.

The Section also specializes in preparing studies on work methods and models in the Ministry by simplifying work procedures for employees and auditors alike, in addition to following up on its work with the Work Methods and Service Development Department, the Civil Service Commission, to review and update all data in the state ministries, including the Ministry of Commerce and Industry (Government Services Directory), which includes all services provided by the Ministry, to be displayed on the website (www.csc.net.kw)

Section Objectives:

- Conducting studies related to work methods and approaches, developing the services, preparing research on simplifying procedures and work maps and assisting the Ministry's departments in issuing their own work manuals.
- Contributing to issuing the procedures manual, the reference manual (services manuals) and other (guidelines) in cooperation with the Ministry's departments.
- Surveying auditors' opinions regarding the level of services provided by the Ministry and measuring their satisfaction with the level of performance.
- Preparing studies to develop public services' quality and proposing setting and developing public services performance standards, using international quality standards.
- Implementing the service quality strategy and programs and coordinating their implementation in cooperation with the Ministry's various service departments.
- Measuring the degree of change in public services performance compared to objective performance standards.
- Preparing studies on organizing data, files and office systems and creating information bases for services, documented with procedural manuals.
- Participating in meetings and committees related to methods and simplification of work procedures and service development and coordinating with the Civil Service Commission in this regard.
- Dividing work according to the capabilities of each employee, so as to achieve optimal results.

Achievements of the Work Methods and Service Development Section:

- 1. The Government Services Directory, located on the integrated automated systems, the Civil Service Commission, as constantly updated in the systems by the Section.
- 2. The Ministry of Commerce and Industry Services Manual, which serves auditors, as displayed on the Ministry's website.
- 3. The Work Procedures Manual for the Ministry as a whole (each department separately), which is located in the Work Methods and Service Development Section, on Flashat system, and is deemed a reference for every department in the Ministry of Commerce and Industry.
- 4. The Ministry of Commerce and Industry's fees guide, which is dedicated to the fees and serves the public and auditors.
- 5. Several development studies were prepared and presented to His Excellency the Minister and the Undersecretary, which aim to improve the level of work of employees and auditors at the Ministry of Commerce and Industry.
- 6. Several various questionnaires were prepared and sent to the Undersecretary of the Ministry, concerned with employees and auditors, in order to determine the extent of job satisfaction in the Ministry. This is in addition to questionnaires to the auditors to determine the extent of their satisfaction with the services provided by the Ministry of Commerce and Industry.
- 7. We participated in several meetings during the year 2022, whether in person or online, on the digital transformation of the Ministry of Commerce and Industry's services and how to implement them. Minutes of those meetings were prepared and sent to the Undersecretary.
- 8. Several workshops were attended on the proposed classifications for the Government Services Directory, at the headquarters of the Central Agency for Information Technology.
- 9. Several reports have been prepared on the advantages of digital transformation of the services provided by the Ministry of Commerce and Industry.

Manuals Prepared by the Work Methods and Service Development Section:

First: Ministry of Commerce and Industry Service Manual

- Data has been updated in the Ministry of Commerce and Industry's Services Manual for the year 2022, as most of the service departments in the Manual have had their services updated, which resulted in new terms and fees being updated.

Second: Ministry of Commerce and Industry Work Procedures Manual:


- The Ministry of Commerce and Industry's Work Procedures Manual has been prepared to include all sectors of the Ministry, including service and non-service departments (each department separately).
- Letters were sent to the Assistant Undersecretaries at the Ministry regarding the approval of the Work Procedures Manual for each sector in the Ministry, in preparation for printing the departments' work procedures manual.
- Personal interviews were held with the Ministry's Assistant Undersecretaries to hand them over the manuals for their sectors and have them approved thereby.
- Procedures manuals were received from various departments in the Ministry over a period of 11 months of continuous work.
- The Ministry of Commerce and Industry's Work Procedures Manual data has been reviewed and updated in line with the electronic changes that occurred in 2022.

Third: Ministries of Trade and Industry Service Fees Manual:

- The Ministry of Commerce and Industry Services Fees Manual is being updated after several departments have changed their fees.
- All new data, services and fees were collected from the Ministry's existing service departments.

Fourth: Government Services Directory (Integrated Automated Systems):

- All the services of the Ministry of Commerce and Industry have been updated for the year 2022, where more than 200 services have been included in the Integrated Automated Systems



Program, the Government Services Directory, and displayed on the Civil Service Commission website (www.csc.net.kw).

 Follow-up is now underway with the Civil Service Commission in the Administrative Development Sector to upgrade most of the service departments after creating new fields in the Government Services Directory system and they will be added to the services of the Ministry of Commerce and Industry.

Monitoring the Development of Organization and Job Descriptions

Job Description and Evaluation Section:

- 1. Providing the Ministry's employees with copies of the Job Description Manual.
- 2. Providing the Ministry's employees, applying for supervisory job interviews, with job descriptions for vacant positions.

- 1) Letter from the head of the Civil Service Commission regarding detailed competencies for organizational units with no competencies.
- 2) Creating a new proposed organizational structure.
- 3) Letter of attachment to the Civil Service Commission regarding the organizational structure of the Ministry of Commerce and Industry and the matching of the competencies card for the Free Zones Department and the competencies for the Storage Areas Department.

Third: Planning and Research Department

The Planning and Research Department supervises the preparation of studies and research related to trade development, prepares short- and long-term plans and their executive programs related to achieving the Ministry's objectives and follows up on their implementation, in addition to providing statistical data related to commercial activity, in cooperation with various information sources. The following is a brief presentation of the Department's achievements for the year 2022.

First: Statistics and Data Field

- 1. Preparing monthly tables and drawings for the "Economic Bulletin", for twelve (12) departments of the Ministry, for the year 2022.
- 2. Preparing quarterly and semi-annual tables and drawings for the year 2022.
- 3. Preparing tables and graphics for the Annual Report for the year 2022.

Second: Research Field

- Preparing and issuing the "Monthly Commercial Bulletin" that deals with commentary on the work and achievements of the Ministry's departments during the month, supported by the necessary statistics and illustrations. The same is displayed on the Ministry's website and is being sent to the office of His Highness the Minister, the Undersecretary, Assistant Undersecretaries and to several parties outside the Ministry.
- Preparing and issuing the Ministry's Annual Report (2021) in Arabic and English languages, which includes all achievements of the Ministry's sectors, accompanied by significant statistics and graphs. The Ministry's annual reports are being distributed to the Minister, the Undersecretary, the Assistant Undersecretaries and to the concerned authorities inside and outside the Ministry. They are also being displayed on the Ministry's website.

Third: The Field of Planning

- 1. Preparing the annual plan for the digital transformation project for the fiscal year (2023-2024).
- 2. Preparing minutes for seven (7) Planning Committee meetings.
- 3. Preparing minutes for four (4) Development Plan Team meetings.

Fourth: Follow up on the Government Action Plan

- Preparing a report on the Ministry's achievements for the year 2022.
- Following up on the implementation of the Development Plan (2023/2024).
- Following-up on the Government Action Plan 2022/2023.

Fourth: Supply Department

During the year 2022, the Ministry continued to assume its role in ensuring the provision of essential commodities and basic materials to citizens at acceptable prices, within its compliance with the state's policy regarding confronting the rise in living expenses by subsidizing commodity prices.


The Ministry is concerned with consumer affairs and protection through its pioneering and major role in supervising local markets to protect the consumer against manipulation and exploitation, to which he may be exposed, in addition to policies related to subsidizing goods and the ration card. Several ministerial resolutions have been issued during the year in this regard.

The policy followed to confront price inflation in the local market stems from the reality of the Kuwaiti economy, which is based on the principle of free economy that the state adopts, the openness of the local market to all world markets, the dominance of supply and demand factors and fair competition among merchants.

Therefore, the Ministry's intervention in setting prices takes place within a narrow scope representing in determining the prices of basic goods and materials necessary for consumer's life yet without interfering in setting the prices of other luxury goods that do not fall under the pricing umbrella. This is left to the factors of supply and demand and the provision of a climate of competition to have the desired effect on price trends and achieve a balance between the interests of the merchant and the consumer.

The Ministry's role in confronting price inflation:

The Ministry's role in confronting inflation and changes in the prices of basic commodities and foodstuffs may be summarized as follows:



- Implementing the government's policy of subsidizing the prices of basic commodities listed on the ration card, which are sold at specific prices pursuant to ministerial resolutions issued in their regard, such as construction materials, e.g., iron, cement and limestone bricks.
- Providing a strategic stock of basic commodities and materials (rice, vegetable oils, powdered milk, liquid milk, sugar, lentils, flour, tomato paste and chicken), which meet the needs of the population for up to six months in anticipation of any emergency circumstances.
- Preventing the export of materials subsidized by the state to ensure their availability to citizens in continuous, abundant quantities and that they do not leak out of the state due to their low prices.

In terms of the current conditions, cooperating with competent authorities, such as the Kuwaiti Catering Company, the Union of Cooperative Societies and the Kuwaiti Flour Mills and Bakeries Company, by providing financial support to these entities in exchange for providing these materials and paying rents for regular and refrigerated warehouses and transportation and storage fees. As for the general objectives that we expect to achieve, they are as follows:

First Objective: Achieving the principle of effective control over the local market to attain the required balance between the consumer and merchant interest together. The Ministry has determined the executive policy to achieve this objective as follows:

- Educating and rationalizing the consumer in his daily dealings in the market and his choice from among different alternatives of goods and services, achieving maximum benefit, in exchange for the prices paid for the goods and services offered.
- Introducing the consumer to the laws and ministerial resolutions issued by the Ministry through various media, which achieves self-monitoring that helps facilitate the Ministry's inspection body.
- The Ministry continuous monitoring of businesses and public markets to prevent fraud and price manipulation in order to protect the consumer.

Second Objective: Maintaining the stability of the citizens' standard of living and ensuring their access to basic commodities at reasonable prices. The Ministry has set the executive policies for this objective, as follows:

- Providing the necessary subsidies for basic foodstuff and materials to alleviate the burden of living costs, in an effort to reduce the prices of similar goods in the local market.
- Providing the necessary subsidies for construction materials, such as iron, cement and limestone bricks.
- Coordinating between the Ministry and other entities responsible for importing and distributing, such as Kuwait Supply Company, the Union of Cooperative Societies, etc., to deliver these commodities to citizens easily and speedily through the ration card route for first-grade materials or the societies' central markets for other items.
- Striving to create a strategic commodity stock of basic materials to achieve the principle of long-term food security.
- Continuous auditing and inspection of distribution entities to ensure that they do not violate the ministerial resolutions specifying individual shares and selling prices.
- Working to link and operate the ration cards automated system in the cooperative societies'
 ration branches, in all regions of the State of Kuwait, in line with the state's policy of developing
 its services in all fields and developing the current system to be compatible with the application




Percentage distribution of ration


