





Second: Initiatives of the Ministry of Commerce and Industry within Kuwait's Strategy to Promote Integrity and Combat Corruption 2019–2025

Kuwait's first strategy to promote integrity and combat corruption for the period 2019 to 2025 was launched to provide a comprehensive guiding framework for Kuwait's efforts in enhancing integrity and combating corruption. The Ministry of Commerce and Industry participated in achieving the strategic objective of "Encouraging the private sector to contribute to enhancing integrity and combating corruption" through the following initiatives: Priority No. 6: "Integrity and Accountability in the Private Sector

Initiative No. (6.1) - Reviewing Accounting Audit Systems and Procedures:

The Ministry of Commerce and Industry has worked on developing accounting audit procedures to ensure enhanced transparency and accountability in the private sector by taking the following steps:

- Coordination with the Kuwait Association of Accountants and Auditors to
- strengthen the capabilities of financial auditors through specialized workshops and training courses aimed at raising the level of financial auditing in the private sector.
- To enhance financial oversight in the private sector, a dual certification and auditing mechanism for financial statements was adopted:
- The first certification process for financial statements is conducted by the Association of Accountants in accordance with internationally recognized accounting standards to ensure the quality of financial audits and reduce risks associated with irregular practices.
- This mechanism is adopted as the initial audit plan, with final certification by the
- Ministry of Commerce and Industry, thereby improving the efficiency of financial
- control operations and raising compliance with transparency standards.

Initiative No. (6.2) - Establishing an Awareness and Training Program on Ethical Business Practices:

The Ministry has implemented a series of awareness and training programs aimed at promoting integrity in the business environment, including:

- Issuance of Ministerial Decision No. 159/2023 concerning the development of
- professional capacities for auditors and the mechanism for their continuous
- qualification and training.
- Incorporation of awareness programs on the Ministry's social media platforms,
- alongside preparing a guidebook on integrity practices in the private sector.
- Launching workshops targeted at Ministry employees responsible for auditing

- companies' financial data, to enhance their knowledge of best practices in combating corruption. Training attendance records for Ministry of Commerce and Industry staff who participated in these workshops and training courses have been submitted to the second task force of the committee.
- Regarding the private sector, the Ministry does not directly conduct training; instead, it
 relies on specialized professional associations and the Chamber of Commerce and Industry to
 support and enhance professional competencies in the market.
- The Ministry's role is to monitor and guide relevant public policies.

1.Initiative No. (6.3) - Monitoring the Implementation of Corporate Governance Principles and Practices As part of the ongoing efforts to strengthen corporate governance in companies, the Ministry has undertaken several measures, most notably:

- Currently working on including an inquiry on the digital portal regarding companies' compliance with governance standards as part of the license renewal procedures via the
- electronic portal, with the aim of building a database of companies that apply
- governance standards.
- Collaborating with the Association of Accountants to include an inquiry on the extent to which companies apply governance standards during the submission and initial auditing of financial statements, aiming to enhance transparency and accountability in financial reports.
- Establishing an electronic database to monitor companies' compliance with governance standards and preparing periodic reports to measure the level of compliance.



The progress achieved in this area is 86% (between the Capital Markets and the Ministry of Commerce).


Third: Support of the Ministry of Commerce and Industry within Kuwait's Industrial Strategy 2035

- Audit and Inspection Office is responsible for reviewing the accuracy and integrity of information, ensuring compliance with policies and regulations, safeguarding assets, and promoting the efficient and economical use of resources, as well as achieving the established operational goals and objectives. This is accomplished through the development of a clear methodology to assess and improve the effectiveness of internal control management and governance.
- The office also conducts administrative and financial audits, identifying any obstacles or challenges that may hinder the performance of departments, and proposing appropriate solutions and recommendations through final reports submitted to His Excellency the Minister. Based on the above, we present the achievements of the Audit and Inspection Office for the year 2024, as follows:

First: Preparation of the annual plan for the Audit and Inspection Office and its submission to His Excellency the Minister.

Second: Submission of the audit report to His Excellency the Minister regarding the Administrative Affairs Department for the fiscal year 2023/2024. Currently, auditing is underway for the Sector of Regulatory Affairs and Consumer Protection.

Third: Conducting field visits by the assigned audit team to inspect and audit the Sector of Regulatory Affairs and Consumer Protection, covering 25 departments and centers, with a total of 30 field visits and 28 official reports issued for these visits.

Fourth: Preparing responses to correspondence related to observations received from regulatory bodies (the State Audit Bureau and the Financial Controllers Agency).

As for freelance companies, the total number of establishment applications submitted reached 9,421, and the number of license applications for freelance companies was 4,792.

- Insufficient media presence, which led to the spread of a lot of incorrect information regarding the establishment procedures.
- Lack of a dedicated social media platform for the department to announce the latest updates and decisions.
- Activation of electronic authentication for notarizing establishment contracts through integration with the Ministry of Justice.

Goals for 2025:

- Improve operations and update establishment procedures by utilizing modern technologies (Artificial Intelligence).
- Ensure automated linkage with all regulatory entities and minimize manual transactions as much as possible.

Second, consumer protection

Consumer protection is an effective regulatory authority in the process of protecting members of the community from any exploitation and combating fraud to ensure the safety of their transactions when purchasing their needs of goods and services they deal with and improve their intellectual situation through awareness. ensure the right of workers in the commercial sector to ensure that commercial activities exercise freedom and fair competition among themselves.

Considering this, the responsibility of the Ministry of Commerce and Industry, represented by the Consumer Protection Department, is determined in the laws that this department is competent to implement.



The Ministry attaches great importance to the efforts exerted to strengthen its

procedures for the protection of consumers and the fight against commercial fraud in all its forms by its agencies and centers covering various regions, through the organization of continuous market inspection campaigns, receiving complaints from the public and treating them in accordance with the legal procedures. in addition, simplified leaflets are issued to make consumers aware of their rights and duties. 

Third: Commercial Control

The Commercial Control Department organized an awareness campaign under the

slogan "Awareness Protects Your Rights and Responsibility Strengthens Your Business", which lasted from September 26, 2024, to December 26, 2024. The campaign covered various locations and periods, including 360 Mall from October 24 to 26, 2024, Capital Mall from November 21 to 23, 2024, and finally The Warehouse Mall from December 26 to 28, 2024.

The campaign aimed to raise awareness among consumers and commercial license holders about the importance of knowing their rights and fulfilling their duties to ensure a fair and successful commercial environment. During the campaign, gifts were distributed to the public, including a bag, a notebook, a pen, and an informational brochure in both Arabic and English. The brochure contained information about laws and ministerial decisions, as well as explanations of the mechanisms for submitting complaints or reports, inquiring about commercial violations, and applying for exemption from violations through scanning the barcode designated for each decision.



Upon reviewing the data for the Commercial Control Department, the following was observed:

The number of inspection reports amounted to 2,544 reports across all supervisors and 3,313 reports in the emergency team. A total of 326 violations were issued across all supervisors and 71 violations in the emergency team. The number of store opening transactions reached 112 across all supervisors and 53 in the emergency team. Additionally, 93 stores were closed across all supervisors and 46 stores in the emergency team.

The number of calls to hotline 135 was 1,342 across all supervisors. The total number of complaints recorded was 3,432 across all supervisors and 712 in the emergency team. Furthermore, the number of complaints received via the portal, WhatsApp, and Sahal reached 25,683 across all supervisors.

statement on the number of transactions processed by the commerci control department in 2024







Statement of the most important transactions of joint-stock companies during the year 2024











relative distribution of licenses for gulf branches in







relative distribution of company licenses by type during year 2024









RELATIVE DISTRIBUTION OF COMMERCIAL REGISTRATION TRANSACTION DURING THE YEAR









Achievements of the Work Methods and Service Development Department During the Year 2024:

the Administrative Development and Training Directorate, particularly during the year 2024. This year marked the beginning of the actual implementation of the digital transformation of the services provided by the Ministry of Commerce and Industry through the "Sahel" application and the ESCWA initiative. This initiative aims to unify electronic government services across Arab countries for individuals and the business sector, in collaboration with the Central Agency for Information Technology (CAIT).

The department also specializes in preparing studies related to work methods and models within the Ministry by simplifying procedures for both employees and clients. It also follows up on its coordination with the Work Methods and Service Development Department at the Civil Service Commission to review and update all service-related data across government entities, including the Ministry of Commerce and Industry. These efforts contribute to the "Government Services Guide," which includes all services provided by the Ministry and is published on the official website: www.csc.net.kw. All data was collected from the various departments within the Ministry using standardized data collection forms.

Department Objectives:

Conduct studies related to work methods and service development, and prepare research aimed at simplifying procedures, mapping workflows, and assisting the Ministry's departments in issuing their respective work manuals.

Contribute to the issuance of the Procedures Guide, Client Guide (Service Guides), and other instructional manuals in collaboration with the Ministry's departments.

Survey client opinions regarding the quality of services provided by the Ministry and assess their satisfaction with performance levels.

Prepare studies to improve the quality of public services and propose performance standards based on international quality benchmarks.

Implement strategies and programs for service quality and coordinate their application in cooperation with the various service departments within the Ministry.

Measure the degree of change in the performance of public services against objective performance standards.

Fourth: Supply department

During 2024, the Ministry continued to play its role in ensuring the provision of essential goods and materials to citizens at acceptable prices, within the framework of the State policy on confronting the rising cost of living by supporting the prices of commodities.

The Ministry is concerned with consumer affairs and protection through its leading role in supervising local markets to protect consumers from manipulation and exploitation, as well as policies related to the support of goods and ration card, and during the year several ministerial decisions were issued regulating labor.

The policy adopted to counter inflation in the local market stems from the reality of the Kuwaiti economy, which is based on the principle of a free economy, the openness of the local market to all markets of the world, the sovereignty of supply and demand factors and the honest competition among traders.

Therefore, the intervention of the Ministry in determining prices takes place within a narrow scope, represented in determining the prices of basic goods and materials necessary for the life of the consumer without interfering in the determination of the prices of other luxury goods that do not fall under the umbrella of pricing. This leaves to supply and demand factors and to provide the climate of competition by having the desired effect on price trends and balancing the interest of the trader and the consumer.

The role of the Ministry in the face of price inflation:

The role of the Ministry in dealing with inflation and changes in the prices of essential goods and foodstuffs can be summarized as follows:

- Implement the government policy of subsidizing the prices of basic commodities listed on the ration card, which are sold at specified prices according to ministerial decisions issued thereon, such as construction materials such as iron, cement and limestone.
- Providing strategic stocks of essential commodities and materials (rice, vegetable oils, powdered milk, liquid milk, sugar, lentils, flour, tomato paste and chicken), which meet the needs of the population for up to six months in case of any emergency.
- Prevent the export of subsidized materials by the state to ensure that they are available to citizens in continuous ample quantities and do not leak out of the country because of the low prices.
- Cooperation with the competent authorities such as the Kuwait Catering Company, the Union of Cooperative societies and the Kuwaiti flour mills and bakeries company by providing financial support to these entities in exchange for the provision of such materials and the payment of the rents of ordinary and refrigerated warehouses and the fees of transportation and storage.

The first objective:

To achieve the principle of effective control over the local market to reach the required balance between the interest of the consumer and the interest of the trader together, the Ministry has defined the executive policy to achieve this goal as follows:

Raising awareness and rationalizing the consumer in his daily dealings with the market and

choosing between the various alternatives of goods and services so that he can achieve the maximum benefit, in return for what he pays as a price for the goods and services offered.

Introducing the consumer to the laws and ministerial decisions issued by the Ministry through the various media, which achieves self-control that helps facilitate the ministry's inspection apparatus.

The Ministry continues to monitor public businesses and markets to prevent fraud and price manipulation in order to protect consumers.

The second objective:

To maintain the stability of the living standards of citizens and ensure their access to basic commodities at appropriate prices, the Ministry has defined the executive policies for this objective as follows:

- Provide the necessary support for food commodities and commodities in order to alleviate the cost of living and to reduce the prices of those in the local market.
- Provide the necessary support for construction materials such as iron, cement, and limestone.
- Coordination between the Ministry and other entities involved in the import and distribution such as the Kuwait supply Company, the Union of Cooperative societies and others to deliver these goods to citizens easily and easily through the ration card for first-grade materials or the central markets of associations for other items.
- To seek strategic commodity stocks of essential items in order to achieve long-term food security.
- Audit and continuous inspection of the distribution bodies to ensure that the ministerial decisions specified for the shares of individuals and their selling prices are not violated.
- Work to link and operate the automated ration card system in the supply branches of cooperative societies in all regions of the State of Kuwait in line with the state policy in developing its services in all fields, and develop the current system to be compatible with the application of the smart card, which will replace the ration card currently in circulation.




proportional distribution of disbursed subsidies during the year 2024
