

The Department conducts inspection rounds and monitors prices through cooperative societies and parallel markets.

This is in addition to keeping an eye on prices in the different seasons to ensure keeping them within limits, monitoring seasons exploitation by outlets, protecting consumers and applying market laws and regulations.

- 1. Sending monthly report on monitoring construction materials and foodstuff.
- 2. Sending reports on health requirements rounds.
- 3. Meeting with the company organizing the work of the new pricing program to train cooperative societies and central markets.
- 4. Conducting a training workshop with 12 cooperative societies and 6 central markets to train them on entering prices to the new program.

Third: Consumer Protection

Consumer Protection is one of the effective supervisory entities in the process of protecting society members against exploitation and combating fraud, so as to ensure their safe transactions when purchasing their needs of goods and the services they deal with. This is in addition to improving their intellectual status through awareness and ensuring the right of workers in the commercial sector in a manner that guarantees commercial activities' freedom of practice and fair competition.

In light of the above, the responsibility of the Ministry of Commerce and Industry, represented by the Consumer Protection Department, is determined by the laws implemented by that Department:

- Law No. (2) of (1995), and the laws amending it, regarding sale prices.
- Law No. (20) of (1976), and the laws amending it, regarding the suppression of fraud in commercial transactions.
- Law No. (10) of (1979), and the laws amending it, regarding the supervision of trade in goods and setting the prices of some of them.
- Decree No. (23) of (1980) regarding the supervision and control of metals and precious stones.

Stemming from the Ministry's keenness to protect consumers against fraud, and for public interest, Resolution No. (368) of (1988) has been issued to form a committee to study consumer protection laws in order to indicate deficiencies therein or any application problems, as well as to suggest appropriate solutions to remedy or overcome such problems. During the year (1989), the committee has reviewed all aforementioned laws and submitted its proposals on the amendments required thereto.

In addition to the above, the Ministry pays great attention to the efforts exerted to enhance its procedures set for protecting consumers and combating commercial fraud in all forms, through the agencies and centers affiliate thereto, covering various regions, as well as by organizing continuous inspection campaigns on markets, receiving complaints from the public and addressing them pursuant to the legal procedures in place. This is in addition to issuing simplified pamphlets to educate consumers about their rights and duties. The following are the key achievements attained in this regard:



Discounts and Prices

- Sale activities have recorded a noticeable increase during 2021, estimated at about 13%, with transactions amounted to (1,284), compared to (1,133) transactions in 2020.
- Special Offer transactions (in cooperative societies / supermarkets) have witnessed (451) transactions in 2021, with an estimated increase of about 21% compared to 2020.
- The number of Special Offer transactions (in commercial shops) amounted to (83), with an obvious decrease of about 36% compared to last year.
- Announced sale transactions (goods, services, crafts) recorded (125) transactions, with a significant decrease of about 16% compared to 2020.
- Distribution Offers (coupon, guide, discount brochure, cards for a group of participating stores) witnessed an estimated number of (16) transactions, with a noticeable increase, estimated at 300%, compared to year 2020.
- Twenty-one (21) Distribution Offer transactions (coupon, guide, discount brochure, cards) took place in 2021, with a clear increase of about 110% over last year.
- Five (5) Cashback Offers transactions took place in 2021.
- Seventy-Seven (77) seasonal and emergency offers transactions were conducted in 2021.
- Transactions linking local price to the prices on foreign and international websites and electronic applications amounted to (17) transactions in 2021.
- Free prize withdrawals amounted to (387) transactions in 2021, with an estimated increase of 69% compared to 2020.
- Free gift distribution transactions amounted to (1,956) in 2021, with an estimated increase of 32% compared to 2020
- General liquidation transactions (commercial license permanent termination and change of the type of commercial activity) amounted to (3) transactions in 2021, with a noticeable decrease estimated at 73%, compared to 2020.

Fifth: Survey Studies and Price Control

Commercial Surveys and Price Control Department 2021 Achievements

Within the framework of implementing the Control and Consumer Protection Sector's plan, the Department has conducted a comprehensive survey on all commodity prices, including foodstuff, consumer goods, services and handicrafts in cooperative societies, parallel markets, restaurants and commercial stores, amounting to (92) visits. Also, the Department has adopted Wasel program for its internal correspondence with your esteemed Sector. Recently, with the rising of steel's prices, we have undertaken extensive visits to monitor those prices and reported the same to the Sector's Undersecretary.


Further, before and during the beginning of the school year, we have also conducted visits to bookshops in all 6 governorates and parallel markets before the blessed month of Ramadan, so as to ensure that no Ramadan commodity price has specifically increased, yet no increase in prices has been spotted.

First: Commercial Licenses for Individuals

In 2021, (2,677) commercial licenses were issued to individuals, distributed over (6) governorates.


Simple Crafts Sector has occupied the first place with (594) licenses, equivalent to 21% of total licenses, followed by Meals Sector with (465) licenses, at a rate of 16%, and then Marketing, Banking and Hotels Sectors have occupied the third place with 14% of total licenses, followed by the other sectors.

Highest share of individual licenses during 2021 was acquired by the Capital, equivalent to (642) of the total licenses. In the second place comes Hawally with a total of (610) licenses, followed by Al-Farwaniyah with a total of (608) licenses. Al-Ahmadi came in fourth place with a total of (421) licenses, while the fifth place was for Al-Jahra with a total of (289) licenses and the sixth and last place was for Mubarak Al-Kabeer with a total of (107) licenses.



Number of individual commercial licenses issued for key activities for the year 2021











Commercial Register Transactions in 2021












Quantity of Gold Jewelry and Precious Stones Stamped during the year 2021

The amount of stamped gold increased in (2021), compared to (2020), by approx. 161%, where it weighed (34,595,112) kg compared to (13,242,576) kg for (2020).

As for the quantities of silver, they increased significantly during the year (2021) from the year (2020) by about 55%, as it weighed (2,453,357) kg compared to (1,587,933) kg.

As for the quantities of precious stones that were examined and evaluated, they decreased by about 31%, amounting to (1,172) in (2021), compared to (892) pieces in (2020), as detailed in the following table:

Second: Trademarks and Patents


There are several ways to distinguish one commodity from another by mere form, including trademarks, which continue to simplify the procedures for registering and documenting trademarks, patents and industrial designs, with a view to stimulate commercial movement.

Total number of trademarks amounted to 60,806 transactions in 2021, with a noticeable increase of about 106% compared to last year. The biggest share of filing a trademark was 38,154 transactions, with an increase of about 105% compared to last year, followed by visas releases, amounting to 11,072 transactions, with an increase of about 132% compared to last year. As for visas, they amounted to 5,616 transactions, with an increase of about 99% compared to last year. Trademarks renewal transactions amounted to 5,499 transactions, with an increase of about 77% compared to last year. Oppositions to a trademark registration amounted to 285 transactions, with an increase of about 265% compared to last year. Document extracts amounted to 87 transactions, with an increase of about 47% compared to last year. The number of grievances was 78 transactions, with an increase of about 767 transactions compared to last year. As for the Agents Register, its transactions amounted to 15 transactions, with a decrease of about 25% compared to last year.



Fifth: Export Development Section

Kuwait's total Kuwaiti products exports to world states in (2021) amounted to about KD (324,113), where Arab states' share amounted to 22%, while foreign states' share amounted to about 18% of total exports and Gulf states' shares accounted for about 60% of total exports. It is noted that this year's exports have increased by about 123% compared to last year.

First: Arab countries

The value of Kuwaiti-origin products that were exported during the year (2021) to these states amounted to about KD (71) million. Most of these exports was to Jordan, with an estimated percentage of 30% of the total exports to Arab countries, followed by Lebanon with an estimated percentage of 24%, then Iraq, with an estimated rate of 22%, and the remaining products were exported to Yemen, Syria, Egypt, Morocco, Tunisia, Libya, Sudan, Algeria, Palestine, Somalia, and Djibouti. An increase in this year's exports has been witnessed, with an estimated rate of about 54% compared to last year.

Second: Other World States

The value of Kuwaiti-origin products exported during (2021) to these states amounted to about KD (59) million. About 28% of these exports were to Belgium, followed by Turkey with an estimated percentage of 22% of total exports to foreign countries. The remaining percentages were concentrated in France, Luxembourg, Spain, Italy and other countries. An increase in exports is noted for this year, estimated at 126% over last year.


Third: GCC Member States

The value of Kuwaiti-origin products exported during (2021) to these states amounted to about KD (194) million. Approx. 45% of these exports went to Qatar, followed by the UAE in the second place with an estimated 22% of the total exports to Gulf states. Remaining percentages were distributed to Kingdom of Saudi Arabia, Bahrain and Oman. An increase in exports of this year is noted, estimated at about 165% over last year.



Kuwaiti-Origin Exports to the States of the World during 2021 compared to 2020



- -Sabah Al-Ahmad Center was received from the Ministry of Transportation. It was equipped and (electrical and construction) works were completed therein. Employees of the Center started resuming their work.
- Electrical works and window maintenance (making ventilation holes in the windows) are completed in East Ahmadi Center.
- Plans were made for the temporary forestry project, following up the project with the municipality and determining the cost with the Ministry of Works (Roads Authority).

The Planning and Research Department supervises the preparation of studies and research related to trade and commercial development, in addition to preparing short and long-term plans and executive programs thereof, as related to achieving the Ministry's objectives, following up on their implementation and providing statistical data related to commercial activity, in cooperation with various sources of information. The following is a brief presentation of the Department's achievements in 2021.

First: Statistics and Data Field

- 1. Issuing the Special Annual Report of the Amiri Diwan, including the following:
 - Licenses of joint stock companies.
 - Public Authority for Industry licenses.
 - Supply Department's achievements.
- 2. Providing and compiling annual statistical data for the year (2021) for all Ministry's activities, along with graphs.
- 3. Providing monthly statistical data on all Ministry's activities, along with graphs.
- 4. Interviewing applicants for information and statistical data and providing them therewith in cooperation with the Information Systems Center.
- 5. Monitoring all changes that occur in the Ministry's activities' sectors, taking the necessary measures to provide statistical data required for the preparation of statistics and bulletins.

Second: Research Field

- Preparing and issuing the "Monthly Commercial Bulletin", which deals with commenting on the work and achievements of the Ministry's departments during the month, supported by the necessary statistics and illustrations. Monthly commercial bulletins are being displayed on the Ministry's website and sent to the Minister's Office, the Undersecretary and the Assistant Undersecretaries and to several entities outside the Ministry.



- Preparing and issuing the Ministry's Annual Report in both Arabic and English languages, for the year (2020), including all Ministry's sectors' achievements, along with key statistics and graphs, to be distributed to the Minister, the Undersecretary, the Assistant Undersecretaries and the concerned parties inside and outside the Ministry, in addition to displaying the same on the Ministry's website.

Third: Planning Field

- Preparing the Development Plan projects for the fiscal year (2020/2021).
- Attending the meetings of the task force following up the projects included in the Development Plan for the fiscal year (2020/2021), preparing minutes of the meetings and following up on the issuedrecommendations.
- Attending the meetings of the Planning Committee of 2021, preparing the minutes of the meeting and following up on the issued recommendations.
- Following-up the Operational Plan of the Ministry of Commerce and Industry for the year (2021).
- Following-up on the Sustainable Development Goals as prepared by the Central Administration of Statistics.

Fourth: Following-Up Government's Work Program

- The Development Plan follow-up data has been entered to the automated system of the General Secretariat of the Supreme Council for Planning and Development.
- The (quarterly) brief report on the Development Plan 2020/2021 has been prepared periodically.
- The report is being prepared and sent to the Audit Bureau on a regular basis.
- Preparing the obstacles to the Development Plan (2019/2020).

Fourth: Supply

During the year 2021, the Ministry continued to undertake its role in ensuring the provision of basic commodities and materials necessary to the citizens, at acceptable prices, within commitment to the state's policy regarding facing the rise in living expenses by subsidizing commodities' prices.

The Ministry is concerned consumer affairs and protection through its leading and major role in supervising local markets to protect consumers against manipulation and exploitation they may be exposed to, as well as policies related to subsidizing commodities and ration cards. During the year, several Ministerial Resolutions regulating that work have been issued.

The policy adopted to confront price inflation in local market stems from the reality of the Kuwaiti economy, which is based on the principle of a free economy adopted by the state, in addition to local market openness to all world markets and the supremacy of supply and demand factors and honest competition among traders.

Therefore, the Ministry's intervention in setting prices takes place within a narrow scope given in determining the prices of basic commodities and materials that are necessary for the consumer's life, without interfering in determining the prices of other luxury goods that do not fall under the umbrella of pricing. This is left to the factors of supply and demand and the existence of a climate of competition by bringing about the desired effect on price trends and achieving a balance between the interest of traders and consumers.



Ministry's role in facing price inflation

The role of the Ministry in facing inflation and changes in the prices of necessary commodities and foodstuffs can be summarized as follows:

- Implementing the government's policy to support the prices of basic commodities listed on the ration card, which are sold at specific prices according to Ministerial Resolutions issued in their regard, e.g., construction materials, such as steel and lime bricks.
- Providing the strategic stock of commodities and basic materials (rice, vegetable oils, powdered milk, liquid milk, sugar, lentils, flour, tomato and chicken paste), which meet the needs of the population up to six months, in anticipation of any emergency circumstances.
- Prohibiting the export of materials subsidized by the state in order to ensure their availability to citizens in large quantities, ensuring that they are not leaked outside the state due to their low prices.
- Cooperating with competent authorities, such as the Kuwait Supply Company, the Union of Consumer Co-Operative Societies and Kuwait Flour Mills and Bakeries Company, by providing these entities with financial support in exchange for providing these materials and paying the rents of regular and refrigerated warehouses and transportation and storage fees. This is for the current situation, but as for the general objectives we expect to achieve:

<u>First Objective</u>: Achieving the principle of effective control over the local market so as to attain the required balance between the interests of consumers and traders alike. The Ministry has set an executive policy to achieve that objective, as follows:

- Consumer's awareness and guidance in terms of his daily dealings in the market and his choice between different alternatives of goods and services, in order to achieve the maximum benefit thereto in consideration for what he pays as prices for offered goods and services.
- Introducing the consumer to the laws and Ministerial Resolutions issued by the Ministry, through the various media channels, achieving a sort of self-control and helping to facilitate the Ministry's inspection body.
- Steady control by the Ministry, through inspecting commercial businesses and public markets, so as to prevent fraud and price manipulation, thus protecting the consumer.



<u>Second Objective</u>: Maintaining a stable citizens' standard of living and ensuring their access to basic commodities at appropriate prices. The Ministry has set an executive policy to achieve that objective, as follows:

- Providing the necessary support for basic commodities and foodstuffs in order to reduce the burdens of the cost of living, and in an effort to reduce the prices of their counterparts in local market.
- Providing the necessary support for construction materials, such as iron, cement, and lime bricks.
- Coordination between the Ministry and other importing and distributing entities, such as Kuwait Supply Company, the Union of Co-Operative Societies, etc., to deliver these goods to citizens easily through ration cards for first-line materials or in supermarkets and cooperative societies for the other items.
- Striving to establish a strategic commodity stock of basic materials, in order to achieve the principle of food security on the long run.
- Continuous auditing and inspection of the distribution entities, so as to ensure that the Ministerial Resolutions specifying individuals' shares and selling prices are not violated.
- Working to link and operate the ration cards' automatic system in supply branches in cooperative societies, in all regions of Kuwait, in line with the policy of the state's policy regarding enhancing its services in all fields and developing the current system to align with the application of the smart card, which will replace the ration card currently in use.

Progress of Subsidy Total Value

During the year (2021), subsidy value amounted to about KD (250) Million, compared to about KD (167) Million in (2020). Hence, it is noticeable that there has been a significant increase in the value of disbursed subsidies in 2021 compared to the previous year, estimated at 50%.

A decrease is also noted in the quantities and value of the basic items included in the ration card in (2021), compared to year (2020), estimated at about 17%, where total basic items amounted to about KD (91.8) Million, compared to KD (110.8) Million during (2020). These items include (basmati rice, sugar, lentils, plain milk powder, vegetable oil, tomato paste, chicken, flour and bread).

As for babies' nutrients and infant formula of all kinds, the value of its subsidy has increased, amounting to KD (6.5) Million during the current year, compared to KD (5.5) Million in 2020, with an increase of 17%.

As for the quantities and value of construction materials subsidized in (2021), their value amounted to about KD (152) Million, compared to KD (50) Million in (2020), due to significant increase by approx. 208%. These materials include (steel, cement, lime bricks, white insulating bricks, concrete, cement bricks, air conditioning, sanitary kits, electrical wires, ceramics and porcelain, external cladding and waterproofing).




