

By reviewing the data of the Consumer Protection Department for the month of July 2025, we found the following:

(31) discount transactions (goods - services - crafts) were issued , an increase of 343% compared to the previous month, and the number of sale transactions reached (51) transactions, a decrease of 22% compared to June 2025, and (31) special offer transactions were issued (for cooperative societies - central markets) with an increase of 55%, and (3) special offer transactions were issued for shops, and (149) transactions were issued for the distribution of free gifts, with an increase of 67%, and the number of transactions reached Seasonal and emergency offers (50) transactions, a decrease of 14% compared to the previous month, noting that (21) recall letters were prepared, an increase of 250% compared to the previous month, and the number of vehicles required for manufacturing defects amounted to (27,189) vehicles, an increase of 1594%.







report on activity amendments in join-stock companies during july 2025 compared to june 2025





transactions of the natural person durng july 2025 compared to june 2025









By reviewing the data on the management of persons companies (main companies) for the month of July 2025, we found the following:

A number of (1672) permanent/temporary licenses were issued for main person companies, an increase of 43% compared to the previous month, while the license renewal transactions were (1309) transactions, an increase of 31%, and the address of (1375) main companies was changed, an increase of 18%, and the number of transactions for changing the trade name reached (228) transactions, an increase of 33As for the transactions of amending the management item, (1058) transactions were made, an increase of 17%, while the amendment or addition of a commercial address was (95) transactions, an increase of 25% compared to the previous month, and the number of transactions for adding a license activity reached (261) transactions, an increase of 24%, while the number of (153) transactions

in adding an activity from a license amounted to (153) transactions, an increase of 39% compared to the previous month, and the number of (743) transactions in adding an activity to the company's contract with an increase of 28%,, and (138) transactions deleting an activity from the company's contract with an increase of 25%, while the change in the activity of the company's contract was (67) transactions with an increase of 24%, and as for the number of transactions for changing the activity of the commercial license, it reached (119) transactions, an increase of 19% compared to the previous month, while in the transactions of capital increase, (111) transactions were made in the current month, with an increase of 18%, and the number of (8) transactions in the reduction of the capital with a decrease of 11%, and a number of (421) was amended. 

The total fees collected for the inspection amounted to an estimated amount of (170,802,335) thousand Kuwaiti dinars, an increase of 5% compared to June 2025, where the Precious Metals Department examined (1,128) grams of artificial stonesof value, and (14,854) grams of other precious stones, and (95,994)) grams of stone inlaid accessory in the current month, and the weight of the diamonds inscribed by the management amounted to (75) grams, and (1,011) grams of platinum, while the platinum examined with diamonds weighed (1,920) grams, and (281) grams of titanium inlaid with diamonds, and (334,323) grams of gold set with precious stones, (104,772) grams of diamond inlaid gold, (6,000) grams of stainless steel watches, (76) grams of silver watches with diamonds, (102,228) grams of 0.05 watches, and (47,691) grams of 0.1 watches, (1,038,265) grams of silver were examined, and (1,017) grams of silver inlaid with diamonds, and (176,194) grams of silver inlaid with precious stones in July 2025.


the index of the weighted value of most important Jul-25 predcious metals in july 2025 compared to june 2025







statement of trademark transactions for july 2025 compared to june 2025







The total Kuwaiti exports of oil and non-oil origin amounted to about KD 442 million, distributed among the GCC countries, Arab Islamic countries, European countries, African countries, the countries of the American continent (North and South), Asian countries and Australia, where the value of certificates for the GCC countries was about KD 227 million, achieving an increase of about KD 121% compared to the previous month, and the percentage of exports of Arab Islamic countries reached about 1202% compared to the previous month, achieving certificates estimated at about KD 152 million, and the value of certificates from European countries reached KD 62 million, an increase of about 3% compared to the previous month, and the value of certificates for the countries of the African continent amounted to KD 532 The value of certificates for the two continental countries amounted to KD 168,000, constituting a decrease of 20% compared to the previous month, while for Asian countries and Australia, the value of certificates amounted to KD 21,000, an increase of 15,896%, and an increase in the total value of certificates for the month of July is observed 2025 for the previous month's certificates, which amounted to 152%.






