Stemming from the role of the Ministry of Commerce and Industry in supporting the national economy and achieving stability, the Ministry and its subsidiaries in the State of Kuwait have been keen to enhance their role by developing policies that contribute to sustainable economic development that achieves the Kuwait's Vision 2035 despite the repercussions of Corona pandemic that ravaged all the economies of countries.

transactions. All transactions and electronic services related to the Ministry of Commerce have been completely digitized, which is estimated at about 427 procedures.

The Ministry of Commerce and Industry and its affiliates have also sought to revitalize Kuwaiti economy and to strengthen Gulf partnerships, through adding several modern activities to support youth capabilities and enable them to keep pace with global economic development. 

First: Commercial Control

Achievements of the Ministry's External Commercial Control Centers During the Year 2020:

The Ministry's external centers undertake an important role in monitoring trade laws, in addition to providing some immediate services, such as gold examination (Central Gold Market and Kuwait International Airport), examining consumer complaints and taking appropriate legal measures upon detecting any violations.

They also make it easier for merchants, within the framework of the principle of decentralization of work, to renew their trade licenses, where the following has been accomplished:

- (32) violations were issued during the year 2020.
- (4121) seizure reports during the years 2019 and 2020.
- (372) stores were opened during the year 2020.
- (51,295) inspection tours during the year 2020.
- (8068) complaints in Commercial Control Centers during the year 2020.
- (73,287) calls were received on the hotline during the year 2020.
- (15,635) catering branches were inspected during the year 2020.
- (36,107) ration cards were issued, identified and added during the year 2020.
- (1107) complaints to emergency teams during the year 2020.

Second: Consumer Protection

Consumer Protection is one of the effective supervisory authorities in the process of protecting society members against any exploitation and combating fraud in a manner that ensures the safety of their transactions when purchasing their needs of goods and services they deal with, in addition to improving their intellectual status through awareness and ensuring the right of workers in the commercial sector, granting that commercial activities would exercise freedom and fair competition among them.

In light of the above, the responsibility of the Ministry of Commerce and Industry, represented by the Consumer Protection Department, is determined by the laws that this Department is competent to implement.

- Law No. (02/1995) and the laws amending it on Sale at Discounted Prices.
- Law No. (20/1976) and the laws amending it on the Suppression of Fraud in Commercial Transactions.
- Law No. (10/1979) and the laws amending it on supervising trade in commodities and fixing the prices of some of them.
- Decree No. (23/1980) on the supervision and control of minerals and precious stones.

In light of the Ministry's keenness to protect the consumer from any case of fraud and for public interest, Resolution No. (368/1988) has been was issued to form a committee to study consumer protection laws, with a view to trace their deficiencies or application problems, as well as to suggest appropriate solutions to overcome such problems. During the year 1989, the Committee has reviewed all laws referred to above and submitted its proposals for the required amendments thereto.

The Ministry pays great attention to the efforts exerted to enhance its procedures for protecting consumers and combating commercial fraud in all its forms, through its affiliated agencies and centers, which cover various regions, as well as by organizing continuous inspection campaigns on markets, receiving complaints from the public and addressing them in accordance with the legal procedures in place, as well as issuing simplified brochures to educate consumers about their rights and duties. The following are the key achievements made in this regard:

Discounts and Prices

- Discounts activity has recorded significant decreases during the year 2020, estimated at about 82%, as the number of transactions was (1,133), compared to (6,427) transactions in 2019.
- Special offer transactions (associations / supermarkets) for the year 2020 witnessed
 (372) transactions, with an estimated decrease of 52% compared to 2019.
- The number of special offer transactions (shops) was (129), with a clear decrease of 86% compared to last year.
- Announced discount transactions (goods, services, crafts) amounted to (149) transac-



tions, with a significant decrease estimated at 54% compared to 2019.

- Distribution offers (coupon, guide, discount brochure, cards for a group of participating stores) witnessed an estimated number of (4) transactions, with a noticeable increase estimated at 300% over the year 2019.
- Distribution offers (coupon, guide, discount brochure, cards) amounted to (10) transactions, with a clear decrease estimated at 52% compared to last year.
- Number of free prize draw transactions amounted to (229) for the year 2020.
- Number of free gift distribution transactions amounted to (1483) for the year 2020.
- Number of general liquidation transactions (permanently cancelation of commercial license, change of the type of commercial activity, etc.) is estimated at (11) transactions, with a significant increase estimated at about 1000% compared to the year 2019.

First: Commercial Licenses for Individuals

The number of (2,602) commercial licenses were issued to individuals during the year 2020, distributed over (6) provinces, noting that these licenses decreased by about 41% compared to those issued during the year 2019.


- The activity of restaurants and snack food ranked the first, where the number of licenses issued for the key activities during 2020 was (154) and (146) licenses, respectively, with the percentage of 6% for each of them.
- Men's barbering licenses came in second place with a percentage of 5% of the number of new licenses issued, amounting to 132 new licenses during the year 2020.
- Grocery activity came the third, with a number of licenses amounting to (119), at a rate
 of 4.5% during the year 2020.

The Capital acquired the highest share of individual licenses during the year 2020 of the total issued licenses, equivalent to (603) licenses during the year 2020. With (487) licenses, and Al-Ahmadi province ranked the second, followed by Al-Farwaniyah in the third place, with (478) licenses, Al-Ahmadi in the in the fourth place with total licenses of (434), while in the fifth place was Al-Jahra province with a total of (431) issued licenses and the sixth and last place was for Mubarak Al-Kabeer province, with a total of (169) licenses.

Number of individual commercial licenses issued for the key activities during the year 2020






Number of Individual Licenses for Trade Activities During the Year 2020 by Provinces










Third: Joint Stock Companies


First: Precious Metals

Quantity of gold jewelry and precious stones stamped during the year (2020):

The amount of gold stamped during the year (2020) decreased by approx. 45% compared to the year (2019), weighed (13,242.576) kg compared to (23,945.199) kg for the year (2019).




Second: Trademarks and Patents

There are many ways to distinguish one commodity from another by mere appearance. Among these means are trademarks. Trademarks and Patents Department continues to simplify the procedures for registering and documenting trademarks, patents and industrial designs and drawings, with a view to stimulate commercial movement.

Total number of trademarks has amounted to 29,456 transactions during the year 2020, with a decrease of about 42% compared to last year, where the biggest share was for trademarks filing, with 18,582 transactions, with a decrease of about 45% compared to last year, followed by visas' posting amounting to 4,782 transactions, with a decrease of about 30% compared to last year. As for trademark renewals, they amounted to 3,100 transactions, with a decrease of about 24% compared to last year.



The Ministry has been active in this field and has agreed to hold (36) exhibitions during the year (2020). All exhibitions were inside Kuwait only, distributed between (20) private exhibitions and (16) exhibitions that were held in the Exhibition Grounds in Mishref.

Sixth: Export Development Section

Kuwait's total exports to the countries of the world during the year (2020) of Kuwaiti products amounted to about (146) million Kuwaiti dinars, where the share of the Arab countries amounted to 32%, compared to (18%) to foreign countries of the total exports. Gulf states percentage amounted to about (50%) of the total exports, in addition to noticeable decrease in exports this year estimated by about 21% compared to last year.

First: Arab States:

The value of products of Kuwaiti origin that were exported during the year (2020) to these countries amounted to about (46) million Kuwaiti dinars, mainly to Iraq with an estimated rate of 39% of the total exports to Arab countries, followed by Jordan with an estimated rate of 24%, then comes Egypt with an estimated percentage of 14% and the remaining products are being exported to Yemen, Syria, Lebanon, Morocco, Tunisia, Libya, Sudan, Algeria, Palestine, Somalia and Djibouti. It is also noted that there has been a decrease in exports this year by an estimated 27% compared to last year.

Second: Other States of the World:

The value of Kuwaiti-origin products that were exported during the year (2020) to these states amounted to about (26) million Kuwaiti dinars, where about 29% of these exports were to Turkey, followed by Belgium in the second place with an estimated rate of about 18% of the total exports to foreign states and the remaining were mainly to France, Luxembourg, Spain, Italy




and other states. It is noted that there was a decrease in exports this year, estimated at about 45% compared to last year.

Third: Arab Gulf States:

The value of Kuwaiti-origin products that were exported during the year (2020) to these states amounted to about (73) million Kuwaiti dinars, where about 38% of these exports were to Qatar, followed by the UAE in the second place with an estimated rate of about 30% of the total exports to Gulf states and the remaining were mainly to the Kingdom of Saudi Arabia, Bahrain, and Oman. It is noted that there was an increase in exports this year, estimated at about 1% compared to last year.

First: Finance Affairs

- Thirty-two (32) contracts were signed to support the development of the Ministry's sectors for the fiscal year (2020-2021).
- First state entity to enter the final account during the off days due to the new Coronavirus pandemic.
- Automation of the temporary personal custodies to settle the personal custodies of the of the agents.
- Automation of electronic linking and conducting transactions through automated systems to avoid the use of manual books.
- Automation of deductions for days of absence from work and delay by the Ministry's employees, from a manual system to an automated system, through the integrated system program.

Second: Administrative Affairs

- Preparing an automated program to send attendance sheets for all Ministry employees through that program, so as to ensure that the said sheets are delivered to the Administrative Department soonest possible, in order to have the relevant data entered on a timely basis and saved.
- Granting the authority to enter leaves and leave permissions for all Ministry employees in the automated system of integrated systems and stopping the manual entry of those leaves and permissions, so as to ensure their speedy arrival from external centers and departments.
- Completion of the Ministry's structure with supervisory jobs by placing a number of (110) supervisory jobs during the fiscal year 2020-2021, distributed as follows: assigning new 35 supervisory jobs and designating and assigning 75 supervisory jobs.
- Granting powers to all Ministry employees to access all days of absence and delays related thereto without referring to the Administrative Affairs Department.
- A number of (205) Kuwaiti employees have been appointed to the Ministry's sectors to implement its terms of reference.
- Replacement of (10) non-Kuwaiti employees.

Third: Public Services Department

- Shuwaikh Center, subordinate to the Control and Consumer Protection Sector, was renovated and opened, as the Center has been exposed to a fire that completely destroyed
 it, including air conditioning, electricity and sanitary works. It has been completely restored, refurnished and handed over to the Commercial Control Department.

Construction and furniture works were completed and the preparation process is pending the Information Systems Sector's completing the systems' infrastructure so that the departments may be transferred, in order to rationalize rents' expenditures.
- The Ministry of Finance has approved increasing the number of cars from 36 cars to 75 cars, with an increase of more than 100%, which will increase the performance efficiency of the Ministry's employees, especially the commercial control sector. The tender has been announced and the awarding and signing of contracts shall take place in the near future.





Department of Work Methods and Service Development Work Methods and Service Development Section:

Work Methods and Service Development Section is one of the key sections in the Administrative Development and Training Department, which is specialized in preparing studies on work methods and models in the Ministry by simplifying work procedures for the employee and the auditor alike, in addition to following up on his work with the Work Methods and Service Development Department in the Civil Service Bureau, in order to review and update all data in the Ministries of the state, including the Ministry of Commerce and Industry (Government Services Directory), in which all the services provided by the Ministry are placed to be displayed on website www.csc.net.kw

- 1. This is in addition to issuing other several guides of the Ministry, as follows:
- 2. Government Services Guide, found on the Integrated Automated Systems of the Civil Service Bureau, which is constantly updated in the Systems by the Section.
- 3. Ministry of Commerce and Industry Services Guide (Guideline), which serves the auditors.
- 4. Ministry's Work Procedures Guides as a whole (each department separately).
- 5. Ministry of Commerce and Industry Fee Guide, which is concerned only with fees and also serves the public and auditors.

Section Objectives:

- Conducting studies related to work methods and ways, developing the service, preparing research on simplifying procedures and work maps and assisting the Ministry's departments to issue their own work guides.
- Contributing to the issuance of the Procedures Manual, Auditor's Guide (services guides) and other (guidelines) in cooperation with the Ministry's departments.
- Tracing auditors' opinion on the level of services provided by the Ministry and measuring their satisfaction with the level of performance.
- Preparing studies to develop the quality of public services and suggesting setting and developing standards for the performance of public services, using international quality standards.
- Implementing service quality application strategy and programs and coordinating their implementation in cooperation with the various service departments of the Ministry.
- Measuring the degree of change in the performance of public services from objective performance standards.
- Preparing studies for organizing data, files and office systems, and creating information bases for services documented with procedural evidence.
- Participating in attending meetings and committees on methods, simplification of work procedures, service development and coordination with the Civil Service Bureau in this regard.

Achievements of the Work Methods and Service Development Section:

First: The Ministry of Commerce and Industry Services Guide (Guideline):

- An E-Book has been prepared for the Ministry of Commerce and Industry's new Services Guide, which is in line with recent electronic developments, to be added on the electronic portal of the Ministry of Commerce and Industry.
- Amendment is taking place to the Ministry of Commerce and Industry Services Guide, as
 most of the service departments included in the guide have updated their services, which
 has resulted in new conditions and fees being updated.
- New Ministry of Commerce and Industry Services Guide is now being printed electronically (E-Book).

Second: Ministry of Commerce and Industry's Work Procedures Guide:

- A work procedures guide has been prepared for the Ministry of Commerce and Industry, including all sectors of the Ministry of Commerce and Industry, including service and non-service departments; each separately.
- Letters have been sent to the assistant undersecretaries in the Ministry regarding the approval of the Work Procedures Guide for each sector in the Ministry, in preparation for printing the departmental work procedures guide.
- Personal interviews were conducted with the assistant undersecretaries at the Ministry of Commerce and Industry in order to hand them over the mechanisms for their sectors and having them approved thereby.
- Procedures Guide has been received from the various departments in the Ministry over a period of 8 months of continuous work.
- The data of the Work Procedures Guides of the Ministry of Commerce and Industry has been reviewed and updated in line with the electronic changes that occurred in 2020.
- Coordination has been made with a printing company to put the Procedures Guide data into flash drives, which include (9) sectors in the Ministry.
- Work Procedures Guide of the departments is being introduced for (9) sectors in the Ministry, and put them on special flash memories for each sector.

Third: Ministries of Trade and Industry Service Fees Guide:

- Ministry of Commerce and Industry Service Gees Guide is being currently prepared at the request of the Undersecretary of the Ministry.
- New data, services and fees were collected from the Ministry's service departments.
- The Ministry of Commerce and Industry Service Fees Guide is being printed electronically (E-Book).

 Copy of the Ministry of Commerce and Industry Service Fees Guide's cover and internal pages have been sent to the Undersecretary of the Ministry for information and opinion.

Fourth: Government Services Guide (Integrated Automated Systems):

- The services of the Ministry of Commerce and Industry were documented and entered to the Integrated Automated Systems Program, Government Services Guide, and displayed on the Civil Service Bureau website: WWW.CSC.NET.KW.
- Follow-up is being undertaken with the Civil Service Bureau in the Administrative Development Sector to update most of the existing service departments that have been amended in terms of terms and fees.

Monitoring the Development of the Organization and Job Descriptions

Organization Development Section

The nature of work of the Organization Development Section is to prepare studies and regulatory reports, which requires the Department to research and review the laws, regulations and resolutions related thereto, as well as to investigate the nature of similar tasks, whether at the Ministry or other authorities and ministries to prevent overlap and duplication of work, in addition to the necessity of direct and indirect coordination with concerned departments and sectors, which consumes time and requires effort and double focus from the officials and workers in the Section, and then coordination with the Civil Service Bureau regarding its approval and then documenting them with the Integrated Automated Systems.

Achievements of Organizational Development Section:

- 1. Attending a periodic meeting at the Civil Service Bureau on controlling the organizational structures growth.
- 2. Holding meetings with the assistant undersecretaries to discuss changing the organizational structure of each sector separately.
- 3. Meeting with the Undersecretary of the Ministry to discuss his vision regarding the organizational structure.
- 4. Evaluating the organizational structure propose for the Ministry and preparing the updated organizational guide accordingly.
- 5. Sending the proposed organizational structure and full terms of reference for the proposed organizational structure to the Civil Service Bureau for review and approval.

Job Description and Evaluation Section

The nature of work of the Job Description and Evaluation Section is to describe and evaluate



the Ministry's jobs, prepare job description cards for all the Ministry's employees and follow up on updating them periodically, or when necessary, in addition to coordinating and cooperating with the Job Description Department at the Civil Service Bureau in terms of job titles and general requirements for job occupants, in order to provide the Ministry with the general database related to job descriptions.

Achievements of the Job Description and Evaluation Section:

- 1. Preparing and reviewing job description guides for the Technical Office Department.
- Participating in the preparation and processing of the visual presentation of the Administrative Development and Training Department to be presented to the Undersecretary of the Ministry.
- 3. Issuing a letter to the Civil Service Bureau regarding "providing the necessary technical support to prepare and update the description", attaching job description guides for all the Ministry's jobs.
- 4. Providing Ministry employees applying for supervisory job interviews with job descriptions for vacant jobs.

Third: Planning and Research

The Planning and Research Department supervises the preparation of studies and research related to trade development, preparing short and long-term plans and executive programs for them, as related to achieving the Ministry's objectives and following up on their implementation, in addition to providing statistical data related to the commercial activity, in cooperation with various sources of information. The following is a summary of the Department's achievements for the year 2019:

First: Statistics and Data

- Issuing the monthly report of the Amiri Diwan, which contains:
 - Shareholding company licenses.
 - Public Authority for Industry licenses.
 - Supply Department Achievements.
- Providing and collecting annual statistical data for the year (2020) on all activities of the Ministry, in addition to graphs.
- Issuing the indicators of the Ministry of Commerce and Industry (2016-2020).
- Providing monthly statistical data on all activities of the Ministry, in addition to graphs.
- Interviewing information and statistical data seekers and providing them therewith in cooperation with the Information Systems Center.
- Monitoring all changes that occur in the sectors of the Ministry's activities and taking



the necessary measures to provide the statistical data necessary for the preparation of statistics and bulletins.

Second: Research

- Preparing and issuing the "Monthly Commercial Bulletin" that deals with commenting on the works and achievements of the Ministry's departments during the month, supported by the necessary statistics and illustrations, to be displayed on the Ministry's website and sent to the office of HE the Minister, the Undersecretary and the Assistant Undersecretaries to several parties outside the Ministry.
- Preparing and issuing the Ministry's annual report in Arabic for the year (2019), which
 includes all the achievements of the Ministry's sectors, accompanied by important statistics and graphs, to be distributed to HE the Minister, the Undersecretary and the Assistant Undersecretaries to several parties outside the Ministry, as well as displaying it on
 the Ministry's website.

Third: Planning

- Preparing the development plan projects for the fiscal year (2020/2021).
- Attending the meetings of the working group to follow up on the projects of the development plan for the fiscal year (2019/2020), preparing the minutes of the meeting and following up on the recommendations issued.
- Attending the 2019 Planning Committee meetings, preparing meeting minutes and following up on the recommendations issued.
- Following-up the Operational Plan of the Ministry of Commerce and Industry for the year (2019).
- Following up on the sustainable development goals prepared by the Central Administration of Statistics.

Fourth: Following up on the Government's Work Plan

- The development plan follow-up data has been entered into the Automated System of the General Secretariat of the Supreme Council for Planning and Development.
- Summary (quarterly)report of the Development Plan 2020/2021 has been prepared periodically.
- The report is being prepared and sent to the Audit Bureau periodically.
- Preparing the obstacles to the Development Plan (2019/2020).



Fourth: Supply

During the year 2020, the Ministry continued to play its role in ensuring the provision of basic commodities and materials necessary for the citizens at acceptable prices, with commitment to the state's policy regarding facing the rise in living expenses by subsidizing the prices of commodities.

The Ministry is concerned with consumer affairs and protection through its undertaking leading and major role in supervising local markets to protect consumers against the manipulation and exploitation they may be exposed to, as well as the policies related to subsidizing goods and ration cards. During the year, several work-regulating ministerial resolutions were issued.

The policy adopted to confront price inflation in the local market stems from the reality of the Kuwaiti economy, which is based on the principle of free economy, on which the state operates, as well as the openness of the local market to all world markets, the supremacy of supply and demand factors and honest competition among traders.

Therefore, the Ministry's intervention in setting prices takes place narrowly; i.e. determining the prices of commodities and basic materials necessary for consumer's life without interfering in determining the prices of other luxury goods that do not fall under the umbrella of pricing, which is left to the factors of supply and demand and the existence of a climate of competition by bringing about the desired effect on price trends and achieving a balance between the interest of merchants and consumers.

Ministry's Role in Facing Price Inflation:

The role of the Ministry in facing inflation and changes in the prices of necessary commodities and foodstuffs can be summarized as follows:

- Implementation of the government's policy to support the prices of basic commodities listed in the ration card, which are sold at specific prices according to ministerial resolutions issued in their regard, such as construction materials; iron, cement and lime bricks.
- Providing the strategic stock of basic commodities and materials (rice, vegetable oils, powdered milk, liquid milk, sugar, lentils, flour, tomato paste and chicken), which meet the needs of the population for up to six months in anticipation of any emergency conditions.
- Preventing the export of materials subsidized by the state to ensure their availability to citizens in continuous abundant quantities and prevent leaking them outside the state due to their low prices.

Cooperating with the competent authorities, such as the Kuwait Catering Company, the Union of Cooperative Societies and Kuwait Flour Mills and Bakeries Company, by providing financial support to these authorities in exchange for providing these materials and paying the rents of regular and refrigerated warehouses and transportation and storage fees. This is for the current situation. As for the general objectives that we expect to achieve, they are:

First Objective: Achieving the principle of effective control over the local market, so as to reach the required balance between the interest of both consumers and merchants. The Ministry has set the executive policy to achieve this objective as follows:

- Consumer's education and rationalization in his daily dealings in the market and his
 choice of the different alternatives of goods and services, so that he would achieve maximum benefit, in return for what he pays as prices for the offered goods and services.
- Introducing the consumer to the laws and ministerial resolutions issued by the Ministry through the various media channels, which will achieve self-censorship and help facilitate the Ministry's inspection team.
- Continuing the Ministry's oversight by inspecting commercial businesses and public markets to prevent fraud and price manipulation in order to protect the consumer.

Second Objective: To maintain the stability of the citizens' standard of living, ensuring their access to basic commodities at reasonable prices. The Ministry has set the executive policies to achieve this objective, follows:

- Providing the necessary support for basic food commodities and materials in order to reduce the cost-of-living burden and in an effort to reduce the prices of their counterparts in the local market.
- Providing the necessary support for construction materials, such as iron, cement and lime bricks.
- Coordination between the Ministry and other importing and distribution entities; such as Kuwait Supply Company, Union of Cooperative Societies, etc., so as to deliver these goods to citizens easily and quickly through the ration card for first-grade materials or societies' central markets for other items.
- Seeking to maintain a strategic commodity stock of basic materials, achieving the principle of long-term food security.
- Continuous auditing and inspection of distribution agencies to ensure that ministerial resolutions specifying individual shares and selling prices are not violated.
- Working on linking and operating the ration cards automated system in the various catering branches at cooperative societies in all regions of the State of Kuwait, in line with the state's policy for developing its services in all fields and enhancing the current system to be compatible with the application of the Smart Card, which will replace the ration card currently in circulation.

Evolution of the total subsidy value:

Subsidy value during the year (2020) amounted to about (167) Million Kuwaiti Dinars, compared to about (209) Million Kuwaiti Dinars for the year (2019), with noticeably significant decrease, amounting to approx. 20%.

Also noted is an increase in the quantities and value of basic materials for the ration card during the year (2020) compared to the year (2019), estimated at about 2%, where the total basic



materials amounted to about (110.8) Million Kuwaiti Dinars compared to (108.8) Million Kuwaiti Dinars during the year (2019). This includes (Peshawar rice, sugar, lentils, plain milk powder, vegetable oil, tomato paste, chicken, lentils, flour and bread).

As for the various types of infant formula and feeders, the value of subsidy decreased to about (5.5) Million KD during the current year, compared to (5.7) Million KD in 2019, with an estimated decrease of about 3%.

As for the quantities and value of the construction materials subsidized during the year (2020), their value amounted to about (50.2) Million Kuwaiti Dinars, compared to (95) Million Kuwaiti Dinars in (2019), with a noticeable decrease estimated at about 47%. These materials include (iron, cement, lime bricks and white insulating bricks), in addition to the materials and services that were added in May 2014, namely (concrete, cement blocks, air conditioning, sanitary kits, electrical wires, ceramics and porcelain, external cladding and waterproofing).



Distribution (%) of the Subsidy Value by Major Groups of Materials During the Year 2020






Total Value of Subsidy by Major Groups of Materials During 2020 Compared to 2019 To the nearest (KD 1000)
