Based on the data collected in the table above, and after analyzing the available information for April 2025, it was observed that the number of new incorporation applications for sole proprietorship companies reached 284. The number of rejected applications was 2,336, while 905 applications were approved. Additionally, 140 approved applications were later canceled after review. A total of 1,683 companies were successfully established, 905 companies are currently in the process of being established, and the total number of approved establishments reached 2,049. Furthermore, the total number of sole proprietorship license applications currently under processing was 763, the total number of issued licenses was 3,683, and the total number of submitted license applications amounted to 2,439.



Upon reviewing the data of the Commercial Control Department for April 2025, it was observed that the total inspection activities resulted in 517 violation reports, marking a significant increase of 295% compared to the previous month. Additionally, 59 commercial license violations were recorded, reflecting a sharp rise of 883%. The number of shop openings declined to 7, representing a 70% decrease, while the number of shop closures increased to 13, showing a 225% rise. Furthermore, the number of submitted complaints increased to 282, which is a 68% rise from the previous month. Lastly, the number of complaints received through the Portal, WhatsApp, and the Sahel App reached 3,651, indicating a 10% decrease compared to March 2025.



Upon reviewing the data of the Consumer Protection Department for April 2025, the following was observed: A total of 5 transactions were issued for discounts (goods – services – consumables), along with 1 transaction for a general clearance, and 78 transactions for sales promotions. In addition, 43 transactions were issued for special offers in cooperative societies and hypermarkets, and 6 transactions for special offers in retail stores. Furthermore, 69 transactions were issued for the distribution of free gifts, and 101 transactions for seasonal and emergency promotions. Moreover, 3 recall notices were issued, marking a 200% increase compared to the previous month, and the number of vehicles recalled due to manufacturing defects reached 7,003, showing a 117% increase from the previous month


Upon reviewing the data of the Shareholding Companies Department for April 2025, the following was observed:

The number of transactions for closed joint stock company incorporation fees was 1. There were 5 transactions for the renewal of main public shareholding licenses, representing a 25% increase compared to the previous month. The number of transactions for renewing main closed shareholding licenses reached 25, marking a 19% decrease. There was 1 transaction for issuing a main closed shareholding license and 1 transaction for canceling a closed shareholding license. Additionally, 25 transactions were made for address changes, reflecting a 19% increase. The number of transactions for issuing public branch licenses was 2, showing a 33% decrease, while 6 transactions for issuing closed branch licenses represented a 25% decrease. There were 10 transactions for renewing public shareholding company branch licenses, indicating a 44% decrease, and 43 transactions for renewing closed shareholding company branch licenses, marking a 139% increase.

There was 1 transaction for canceling a public branch license, and 4 transactions for canceling closed branch licenses, which is a 300% increase.

Furthermore, there were 3 transactions for adding activities, showing a 25% decrease, and 3 transactions for removing activities, reflecting a 50% increase compared to the previous month. Finally, there were 2 transactions for replacing lost auditor practice licenses and 271 transactions for authenticating auditor signatures, representing a 40% increase from the previous month.



Upon reviewing the data of the Commercial Licensing Department (Natural Persons) for April 2025, the following was observed: A total of 82 commercial activity licenses were issued, representing a 21% increase compared to the previous month. Additionally, 49 new licenses for craft activities were issued, marking a 36% increase. 80 commercial registration certificates were also issued, reflecting a 4% increase.

Renewal transactions for natural persons' licenses reached 598, showing a 15% increase from the previous month. Address changes numbered 251, with a significant 51% increase. Transactions for changing or amending trade names amounted to 73, reflecting a 143% increase. Activity modifications totaled 39, marking a 95% increase.

License cancellations reached 660, representing a 36% decrease. The number of transactions for transfer to heirs was 13, while changes to heirs' agents amounted to 1 transaction. License assignments for commercial activities totaled 31, showing a 94% increase, and assignments for craft activity licenses numbered 17, with a 13% increase compared to the previous month. Finally, 2 brokerage booklets were issued, and 13 brokerage booklets were renewed for natural persons, marking a 117% increase from the previous month.

# transactions of the natural person during april 2025 compared to march 20252025





Upon reviewing the data of the Commercial Licensing Department (Legal Entities) for April 2025, the following was observed: A total of 2 new licenses were issued, reflecting a 33% decrease compared to the previous month. 26 licenses were renewed, showing a 44% increase.

As for address change transactions, 1 address was changed, representing a 67% decrease. Additionally, 27 replacement licenses (for lost licenses) were issued for legal entities, marking a 13% decrease compared to the previous month.

A total of 195 commercial licenses were issued across various sectors. The highest number was in General Trading Activities and Related Services, with 98 licenses issued to natural persons. This was followed by Maintenance and Repair Services Activities (Simple Crafts) and Related Services, with 32 licenses, and then Accommodation and Food Services Activities and Related Services, with 20 licenses issued during April 2025.

Upon reviewing the data of the Partnerships Department (Main Companies) for April 2025, the following was observed:


A total of 1,287 permanent/temporary licenses were issued for main partnership companies, representing a 21% increase compared to the previous month. License renewal transactions amounted to 1,025, showing a 19% increase. Address changes were made for 1,317 main companies, reflecting a 55% increase. The number of trade name change transactions reached 202, also showing a 55% increase.

Management clause amendments totaled 799 transactions, marking a 41% increase, while amendments or additions to trade addresses were 87, with a 53% increase. Additions of licensing activities numbered 196, representing a 43% increase, and removals of activities from licenses were 112, showing a 40% increase.

Adding activities to company contracts reached 497 transactions, a 13% increase, while removals of activities from company contracts totaled 103, reflecting a 30% increase. Activity changes in company contracts numbered 58, with a 32% increase. Changes to commercial license activities totaled 79 transactions, marking a 27% increase from the previous month.

Capital increase transactions amounted to 85, representing a 9% increase, whereas capital reduction transactions were 5, showing a 17% decrease. Share distribution amendments totaled 329, marking a 46% increase.

Partner entry transactions reached 682, a 35% increase, while partner exit transactions totaled 717, showing a 42% increase. Company dissolution and liquidation transactions were 58, reflecting a 69% decrease. Legal entity changes transactions numbered 40, a 18% increase for the current month. Requests for duplicate licenses from the Companies Department totaled 210, showing a 7% decrease compared to the previous month. Printed extract or certificate requests amounted to 12,710, reflecting a 38% increase. Finally, license reissuance based on the Committee for Status Adjustment decisions totaled 6, showing a 75% decrease compared to March 2025.






## Reviewing the data from the Department of Precious Metals for April 2025, the following was observed:

The total fees collected for examinations amounted to approximately 537,000 Kuwaiti Dinars, reflecting an increase of 154% compared to March 2025. The Department of Precious Metals examined 25 grams of titanium diamond, 4,020 grams of synthetic precious stones, and 3,579 grams of other precious stones. Additionally, diamond-embedded accessories weighing 31 grams and stone-embedded accessories weighing 67,632 grams were inspected during the current month.

The weight of diamonds examined by the department reached 125 grams, while 3,159 grams of platinum were inspected. The weight of platinum embedded with diamonds was 907 grams, and titanium embedded with diamonds totaled 132 grams.

Regarding gold, the amount examined reached 5,429,305 grams, with 411,804 grams of gold embedded with precious stones and 181,463 grams of gold embedded with diamonds. Furthermore, 88 stainless steel-ceramic watches, 84 silver watches with diamonds, 129,871 grams of watches weighing 0.05 carats, and 47,484 grams of watches weighing 0.1 carats were inspected.





# the relative distribution of silver weight in april 2025 compared to march 2025





Upon reviewing the data from the Real Estate Management Department for the month of April 2025, it has been observed that a total of 73 transactions were processed, compared to 65 transactions in March 2025, reflecting an overall increase of 12%. These transactions encompassed nine different categories. The number of real estate brokerage license issuances reached 7, indicating a 56% decrease compared to the previous month. Only one transaction was recorded for the addition of a deputy to a brokerage license, while two transactions were processed for the renewal of a deputy, representing a 100% increase. Additionally, there were four transactions related to the renewal of real estate broker identification cards, marking a 33% increase. One transaction was registered for the issuance of a broker ID for a deputy.

Regarding license cancellations, ten brokerage license cancellation requests were submitted, reflecting an 11% increase. Renewal requests constituted the highest volume, with a total of 35 transactions, showing a significant increase of 67%. Furthermore, one certificate was issued under the "To Whom It May Concern" category for the month. Lastly, the number of newly issued real estate broker identification cards totaled 12, which represents an 8% decrease compared to the previous month.



Upon reviewing the data from the Anti-Money Laundering and Counter-Terrorism Financing Department for April 2025, a noticeable decline was observed across real estate, currency exchange, and precious metals transactions. Renewal and amendment requests dropped by 60% in the real estate sector, 100% in currency exchange, and 50% in the precious metals sector compared to the previous month. Additionally, office audit procedures recorded a 100% decrease across all three sectors. Requests for the appointment of compliance officers also declined—by 25% in real estate, and by 100% in both currency exchange and precious metals. Furthermore, transactions related to instruction forms in the real estate sector decreased by 100% compared to March 2025.

Exports to GCC countries totaled KD 131 million, reflecting a 45% decrease compared to the previous month. 




