Based on the data collected in the table above, and upon analyzing certain available figures for the month of May, it is observed that the number of new establishment applications for partnership companies amounted to 57. The number of rejected applications reached 3,631, while 1,239 applications were approved. Furthermore, the total number of approved applications that were later canceled after review stood at 144. During the same period, 1,801 companies were officially established, and 1,239 companies are currently in the process of being established. The total number of fully approved applications reached 2,574.

In addition, the total number of partnership company license applications currently under issuance was 947. The number of licenses issued reached 3,312, while the total number of submitted license applications amounted to 3,049.

These figures reflect the Kuwait Business Center's commitment to improving the ease of doing business, enhancing the efficiency of company registration and licensing processes, and supporting the growth of partnership companies within the State of Kuwait.

It is noted from the table above that the total number of newly registered establishment applications for micro-enterprise companies and freelance licenses reached two (2) new applications, with 565 applications rejected, and 262 applications approved.

Additionally, the total number of approved applications after review for micro-enterprise companies and freelance licenses included 26 canceled applications, 654 companies established, 262 companies under establishment, and 775 total approved applications.

As for micro-enterprise freelance licenses, a total of 487 licenses were issued for established companies, 717 applications were submitted, 664 licenses were issued, and 61 applications are currently under issuance during May 2025.

Commercial Control Department – May 2025 Report

Upon reviewing the data for the Commercial Control Department for May 2025, the following is noted: The inspectors' activities resulted in the issuance of **758 violation reports** during May, representing an **increase of 52%** compared to the previous month. The number of commercial violations recorded in May 2025 was **49**, reflecting a **decrease of 17%** from the previous month.

Additionally, **6 stores were opened**, marking a **14% decrease**, while the total number of complaints received reached **266**, showing a **6% decline** compared to the previous month. Complaints submitted through the portal, WhatsApp, and the "Sahl" application totaled **3,585**, indicating a **2% decrease** from April 2025.

By reviewing the data of the Consumer Protection Department for the month of May 2025, we found the following:

(35) discount transactions (goods - services - crafts) were issued, with an increase of 600% compared to the previous month, and the number of sale transactions reached (65) transactions, a decrease of 17%, and (23) special offer transactions were issued (for cooperative societies - central markets) with a decrease of 47%, and (2) special offer transactions were issued for shops, with a decrease of 67%, and the distribution of free gifts amounted to (192) transactions. The number of seasonal and emergency offers transactions reached (83) transactions, a decrease of 18% compared to the previous month, noting that (3) recall letters were prepared, and the number of vehicles required for manufacturing defects amounted to (349) vehicles, a decrease of 95%.



report on activity amendments in joiny-stock companies during may 2025 compared to april 2025





By reviewing the data of the Commercial Licenses Department (Natural Person) for the month of May 2025, we found the following:

(123) licenses with commercial activity were issued, an increase of 50% compared to the previous month, while the transactions for the issuance of a new license with a professional activity amounted to (53) transactions, an increase of 8%, the transaction of the commercial registration certificate amounted to (84) transactions, an increase of 5%, and the transaction of license renewal amounted to (587) transactions, a decrease of 2%, and the address was changed, where the number of transactions reached (251). The number of transactions for changing or amending the trade name reached (57) transactions, a decrease of 22%, and for the transactions of modifying the activity, (24) transactions were made, with a decrease of 38%, while the cancellation of the license was (245) transactions, with a decrease of 63% compared to the previous month, and the number of transactions for the transfer of heirs reached (13) transactions, as for the change of the heirs' agent, the number of (2) transactions for the month of April 2025, the number of (48) license waiver transactions with a commercial activity with an increase of 55%, and the number of (10) license waiver transactions with a professional activity with a decrease of 41%. 




proporational distributional of partnership licenses during may 2025


By reviewing the data of the Precious Metals Department for the month of April 2025, we found the following: The total fees collected for the inspection amounted to an estimated amount of (366,408,090) Kuwaiti Dinars, a decrease of 32% compared to April 2025, where the Precious Metals Department examined (840) grams of artificial stonesof value, and (19,552) grams of other precious stones, and the accessory of the diamond restaurant weighed (80) grams, and (78,779 grams of stone inlaid accessory, and the weight of the diamonds examined by the department was (251) grams, and (161) grams of platinum, while the platinum examined with diamonds weighed (569) grams, and (340) grams of diamond-inlaid titanium, with regard to the amount of gold examined weighing (4,121,168) grams, and (402,302) grams of gold inlaid with precious stones, (224,896) grams of diamond inlaid gold, (193) grams of stainless steel-ceramic watches, (129,277) for 0.05 watches, and (57,685) grams for 0.1 watches, (7,497,430) grams of silver were examined., 2,373 grams of silver inlaid with diamonds, and (261,791) grams of silver inlaid with precious stones in May 2025.







statement of trademark transactions for may 2025 compared to april 2025







By reviewing the data of the Department of International Relations (Kuwaiti Certificates) for the month of May 2025, we find the following:

The total Kuwaiti certificates of oil and non-oil origin amounted to about KD 272 million, distributed among the GCC countries, Arab Islamic countries, European countries, African countries, the countries of the American continent (North and South), Asian countries and Australia, where the value of certificates for the GCC countries was about KD 102 million, achieving a decrease of about 22% compared to the previous month. The number of certificates in the Arab Islamic countries increased by about 682% compared to the previous month, achieving certificates estimated at about KD 88 million, and the value of certificates from European countries reached KD 82 million, and the value of certificates for the countries of the African continent reached 10 thousand, a decrease of 97%, and the value of certificates for the countries of the two continents of the Americas reached 49 KD 1,000, a decrease of 77% compared to the previous month, while for Asian countries and Australia, the value of their certificates amounted to KD 39,000, an increase of 3677%, and an increase in the value of total certificates for the month of May 2025 for the previous month's certificates, which amounted to 21%.





relative distribution of transactions conducted using ration card may 2025


